## COMMODORE

At the December 27 Special BOG meeting, the motion to enter into negotiations for the swale property was defeated. Discussion during the meeting was lively as many questions were asked. Feedback after the results were announced indicated that there were too many questions still unanswered and members felt uneasy with proceeding further. Additionally, many members felt that the assessment would cause too great a drop in membership. Many members still support the acquisition of land for SMSA.

As a result of discussions from the January BOG meeting, two committees were formed. The first will be called the SMSA Facility Requirements Committee and will be chaired by John Weir. The purpose of this committee will be to formulate the basic requirements of property and facilities needed by SMSA. The second committee is called the Swale Committee and will be chaired by Stovy Brown. The purpose of this committee is to examine the feasibility of the property located near the small boat swale at Calvert Marina and to generate different revenue producing ideas. This committee has BOG approval to spend up to \$5000 for the purpose of acquiring appraisals, surveys,

and environmental studies. Both groups will work quickly to generate data to be presented to the general membership. Stovy has already met with Matt Gambriel and will have met with Skip Zahniser by the publishing of *The Clew*.

One of the biggest disappointments of this land acquisition endeavor has been the response from the membership. Most of the discussion, comments, and response have been from a relative minority of the membership. If you have any feelings on this matter, please contact the chairmen of either committee or any of the officers/governors of SMSA.

Don't forget the upcoming cruising meeting and race management seminar. The sailing season is just a few short months away.

### DRAFT MINUTES BOARD OF GOVERNORS MEETING DECEMBER 6, 2001

Vice Commodore Barbara Herbig called the meeting to order at 7:30 p.m.

**Secretary** – The minutes from the November 8 meeting were reviewed and approved with two changes.

**New Business** – Stewart Buckler gave a presentation of our SMSA Database Management. He gave background information on how the database has evolved from a paid service to him volunteering to maintain the database. For the last eight years he has maintained the official records for the club which include: all the information in the yearbook, mailing labels for club business, email addresses, renewal forms for club dues, etc. He can sort any information in various ways for reports for the BOG. He has volunteered his time and wants to continue to maintain the database. Discussion followed about accessibility of the database to BOG members, specifically the membership governor and secretary. There was discussion possibility of putting the database on the website with read only/password protected access to BOG members. It was noted that the database information has not always been accessible and prompt when a quick turnaround is needed. It was decided that several avenues need to be investigated before any decision can be made on the accessibility issue and that Stewart should continue to maintain the database for now. The BOG applauded all the hard work and excellent job he has done.

**Treasurer** – David has no report at this time.

**Vice Commodore** – Barbara has been in contact with LCYC and has sent them a copy of the preliminary SMSA schedule so that they can set their operational schedule. Walt has worked with Bill Moessner to get the cruising trophies for 2001 ordered. She added that if the governors have any special awards to order, you should get in contact with Bill Moessner.

**Race** – Shawn had nothing to report.

**Cruise** – Walt reported that they have a great cruise program scheduled and he is looking forward to next year.

**DON STAAKE**

SMSA has lost a pioneer with the passing of Don Staake on January 10. Don was a key-organizing member in the early years, serving in a number of offices, including that of Commodore in 1978. While Don and Peg did some racing, they were most prominent as cruisers, rarely missing a club voyage. The Staakes donated the Happy Hour Cruising Trophy in 1980.

Don was an engineer at the Applied Physics Laboratory of Johns Hopkins for most of his professional career. He specialized in radar and microwave engineering. His most significant accomplishment had to do with enabling American aviators to evade Soviet-made missiles in Vietnam. In the 1980's, he personally designed and directed installation of a microwave system linking the various elements of The Johns Hopkins University.

Many of us regarded him as an expert sailor, a charming friend, and a competent club officer. The family may schedule a memorial service in a few months.

<b>POLICY AND PLANNING LAND ACQUISITION</b>
---

The votes on the land acquisition motion were 87 No and 74 Yes. Fairly close to passage, but there were only 41 Pledges of \$550.

Forty-one Memberships [Individual, Family or Emeritus], out of about 200 Memberships in the Association [about 300 voters] pledged to join in the acquisition. Even using available Screwpile Lighthouse Regatta money, we needed 150 Pledges to go ahead.

The Pledge process was included to avoid a situation of passage but then, after dropout by those not willing, producing insufficient dollars to go ahead and resulting in a decimated, still landless club. The 60-day process is in the By-Laws to provide a period for information, discussion and thought before vote by mail – encouraging all members to participate. It all worked. The answers were No and No.

Membership renewals for 2002 require only the usual, annual dues.

I hope that we keep moving. Our days of clubhouse and swale for peanuts are numbered.

## THE RACER'S EDGE

In this wintry February, let us return to those Southern Maryland days of yesteryear when the days were hot and humid and the evenings were quite balmy. You are the renowned (and feared) skipper of PEDAL TO THE METAL, known for your cunning and wit as well as your aggressiveness on the racecourse. You find yourself once again sailing against your arch rival WEE WILLIE skippered by that (expletive deleted) Poulet Poop in a Wednesday evening race ... this race characterized by the balmy weather with a gradually dying breeze. Your only hope is to maintain your slight lead over WEE WILLIE, and finish before the wind dies completely and the 2-hour time limit expires.

As you beam reach on a port tack at a blistering 1-knot near the Solomons Island Harbor entrance, you are chagrined to see that WEE WILLIE, who is above you and also on port tack, is overtaking you with perhaps a breeze of his own! As the sun sets in the west (it is after all late in the month of August), you decide you must reach up, force up WEE WILLIE, and then capture the wind he seems to be monopolizing. You put your plan into action.

You change course to close on WEE WILLIE from your clear ahead leeward position, and, as he attempts to drive over you using his private breeze, you force him up into the wind where he stalls out, allowing you to continue onward after falling off to your original heading. As you sail onward without as much as a by your leave toward WEE WILLIE you hear a plaintive cry from Poulet Poop, "PROTEST!" You are quite confident that you as leeward clear ahead boat had all the rights in the world ... so you go to the Protest Hearing confident of victory over that poked sea scum Poulet Poop.

You lose the protest and are thrown out of the race! Why?

Rule 23.1, Racing at Night, of the SMSA General Sailing Instructions states that between sunset and sunrise, a right of way, clear ahead boat "shall maintain her proper course" so that an overtaking boat can pass to windward at least three overall lengths from the leeward boat! The Protest Committee further stated to you, and to Poulet Poop, who of course was all smiles, that the intent of Rule 23.1 is to assure that faster boats (WEE WILLIE) attempting to safely pass slower leeward boats (PEDAL to the METAL) at night are given some protection from course changes by the leeward boat that may be hard to see or to respond to in the dark hours after sunset. The Protest Committee also stated that your "proper course" was to maintain your initial heading toward Solomons Island Harbor entrance; and it could not be conclusively proved by you or anyone else that a wind shift had occurred and thus your proper course had suddenly shifted toward WEE WILLIE.

Therefore, the Protest Committee ruled that you were in violation of SMSA Rule 23.1, and you are disqualified!

As you pugnaciously stomp back to the bar at Zahniser's Pool to get a stiff drink, you vow that you need to once again re-read the General Sailing Instructions found in the Annual SMSA Race Circular in order to prevent such disasters in the future.
