## APPROVED MINUTES BOARD OF GOVERNORS MEETING March 6, 2003

### OFFICERS AND GOVERNORS PRESENT:

The Commodore called the meeting to order at 7:42 p.m.

### Commodore's Opening Remarks

- We have lost three sailing friends in the last few months. Tim will be setting aside three pages for a memorial to Paul and Anna Grisso and Nuran Miller. Charlotte inquired about adding Doris Hooper in the memorial. Walt will contact Bill Hooper regarding this.

### Treasurer –

- The treasurer reported that we have \$21,930 in our checking account and \$54,758 in our money market account. Our revenue, so far this year, is \$35,732, of which we have spent \$15,002, which is a little ahead of our budgeted spend plan. We are \$1,836 behind in membership dues renewal at this time. In the February 23 revised budget, \$3,500 was subtracted from the projected income (projected membership dues), and the commensurate expenses were subtracted from several governors' budgets. If there are no problems with the newly revised governors' budgets, we will consider Version 5 dated February 23 as our balanced budget. [There were no objections voiced.]

- After consultation with Askey, Askey & Associates (our new accountants), it was determined that we are, in fact, required to pay Maryland state taxes. Our former accountant, Mr. Dan Long, has figured the Maryland state income

taxes for 1999/2000/2001 and concluded that we owe \$3,048 for those years—not counting interest or penalties. We will send a cover letter along with our payment requesting a waiver to avoid paying penalties and late filing fees. We will need to pay the interest however.

- Jim briefly discussed a phone conversation that he had with his counterpart in the Fishing Bay Yacht Club in Deltaville. FBYC's treasurer was very forthcoming in sharing their lessons learned with financing the construction of a new clubhouse recently.

**Vice Commodore** – The Vice Commodore reviewed the upcoming calendar with the BOG.

**Race** – The Race Governor reported he has received 40 Annual Race Entry Forms and Fees as of February 24. The first Spring Frostbite Race had 3 boats participate. The SMSA River Marks, K and V, were upgraded and set prior to the Frostbite Races. The RC Boat has had the bottom painted and will be launched soon. There is still interior cleaning and maintenance to be completed since the scheduled day was snowed out. The SMSA Bay Marks, D and E, have been inspected for repairs and work will begin soon. SMSA Scorer, Stewart Buckler, has developed the needed spreadsheet to assist with the Wednesday Night Race program. The program will feature weekly-adjusted ratings and season standings in respect to number of awards earned. The Wednesday Night Races will be informal, more fun, and still challenging for all participants.

**Cruise** – The Cruise Governor reported that the cruise schedule has been finalized. It is four pages long—lots of cruises! Gene Norris will lead the Opening Day Cruise.

**Junior** – The Junior Governor gave a lease agreement to the Commodore for signature which after signature will allow the use of six FJ's. Dave has received five high school junior membership renewals. Dave is also looking into purchasing another safety boat through the foundation. He will be taking it on a sea trial before any consideration to purchase the boat.

- Sailing Camp registration will be on March 20 following the high school sailing practice.

**Women's** – The Women's Governor reported there were 20 people at the racing seminar. It was a good seminar.

**Rear Commodore** – The Rear Commodore inquired about the Nautical Flea Market. He asked what program it belongs to and if it did not belong to anyone, maybe we should assign it to a governor. Discussion followed and a decision was made to query any interest in holding the Nautical Flea Market through *The Clew*.

**Social** – The Social Governor reported the Birthday Party is all set for Saturday, March 8 and will begin with cocktails at 6:00 p.m. and appetizers and dinner will be served at 7:00 p.m. Opening Day planning is underway. BOG members will act as Hosts for this event, which will be conducted on April 5 beginning at 9:30. Each BOG member will be responsible for a breakfast item to share with the membership. The Flag Ceremony will be coordinated with Frank King in the coming weeks and final preparations for activities will be completed by the Commodore, Social Governor and Social Committee. To extend the olive branch, Flag officers of LCYC and SIYC will be invited to attend.

**Publicity** – The Publicity Governor was not present. Tim report submitted through email a March 2003 – Publicity Governor Report. The BOG decided to discuss this report at the next BOG.

**Facilities** – The Facilities Governor reported:

- We have 12 new chairs and all the old chairs have new tips on the legs.
- The clubhouse floors have been waxed.
- On March 22 there will be a Spring Cleanup at the clubhouse. Please encourage all members and racers to get a team together.
- The new policy for using the clubhouse will be coming out on our web site. There are significant new rules for using the clubhouse such as: \$100 deposit required for the use of the clubhouse and \$200 club use fee for non-members which is non-refundable.

**Membership** – The Membership Governor reported our membership renewal status for 2003: Overall 85% not counting the Juniors. This breaks down to: 16 emeritus; 42 individual; 110 family;

and 4 juniors. There are 26 unpaid renewals, including 10 confirmed resignations. Of the remaining 16 unpaid members, 8 have verbally indicated their intent to pay. Intentions are unknown for the remaining 8 members. Those who have indicated intent to pay have been included in the yearbook listing, but will be dropped from the mailing list if not paid prior to the next meeting.

- Race fees collected include 41 big boats and 16 small boats.

- We have 4 former member rejoins (all family) and 2 new members (1 family and 1 individual)

- Production ready rosters for membership, boat name, sail number, and subscription has been given to Tim. Will do a final update with Tim upon his return if there is still time.

- Received a nice email of resignation from the Parmentiers. They send their best to the BOG and friends.

*Motion:* A motion was proposed to approve the new membership application from Robert Reed who is sponsored by Frank King.

*Result:* The motion was seconded and unanimously passed.

*Motion:* A motion was proposed to approve the new membership application from Charles Stein and family. Rod Schroeder sponsors them.

*Result:* The motion was seconded and unanimously passed.

The Commodore called for a short break in the BOG meeting.

### **Old Business**

#### **Membership Renewal Form Issues/prorating of memberships** –

Rod Schroeder reported that there are no set rules for or against prorating membership dues. It has been done differently over the years. There are several options we can adopt. They are:

- Assess full membership dues to June. Prorate half dues July through December.

- Assess full dues January through April. Prorate May to December.

- Assess full membership dues January through September.

Discussion followed.

*Motion:* A motion was proposed to assess full membership dues to June. Prorate half dues July through December.

*Result:* No second – motion withdrawn.

*Motion:* A motion was proposed to assess full dues January through April. Prorate May to December.

*Result:* No second – motion withdrawn.

*Motion:* A motion was proposed to assess full membership dues for the entire year; except for the last 3 months, which would be rolled over into the next year.

*Result:* Seconded and passed with 1 opposition.

**Clew publication policy and member forum** – Delayed until the next BOG meeting.

**P&PC recommended by-laws changes** – Delayed until the next BOG meeting.

**P&PC BOG policy review status** - Delayed until the next BOG meeting.

**Report from Capital Planning Committee** – Carl Feusahrens reported that the committee has been trying to have a meeting through email and it is not working. We will need to set up a meeting.

**Non-member Race Fees** – Clarke McKinney reported that the non-member race fees are currently \$100 for members. Non-members are getting a lot of benefits being able to race with SMSA. A significant increase in our non-member race fees is needed. He suggests a \$250 race fee. Discussion followed.

*Motion:* A motion was made to allow non-members to race on an annual basis.

*Result:* The motion was seconded and passed with 1 opposed.

*Motion:* A motion was made which stated that an annual fee can be assessed for non-member racers.

*Result:* Seconded with discussion.

*Motion Changed:* A motion was made which stated that an annual fee equivalent to family membership dues and annual big boat racing fees can be assessed for non-member racers.

*Result:* The motion was seconded and passed unanimously.

### **New Business**

**SMSA Website Update Status** – Dan Shannon, who manages the framework for the SMSA

website, briefed the BOG on how we can develop a secure area on our website. He reported that Ron Spicuzza provides the website free of charge and a secure area would cost our club a monthly fee. He discussed 2 different ways to develop a secure site and the pros/cons of each. The BOG thanked Dan for all his hard work.

**BOG Special Meeting, Purpose: alignment of programs with goals** – Stovy made a recommendation at our last BOG meeting, which was published in the March *Clew*, for the alignment of programs with our goals. Do we need a special meeting for an open discussion to align our programs with our goals? Don Behrens provided an excellent summary of the intent of the recommendations provided by Stovy. Walt asked the BOG to take a step back and look at the whole picture, set goals and review goals. Think about a special meeting. We will bring this up again next month.

**Tragedy** – Charlotte thanked Barbara Herbig for taking the time to send emails to all our SMSA members and friends on the recent tragic passing of Anna and Paul Grisso.

**Awards** – Carl Feusahrens suggested that we review awards to make sure they say what we want them to say. Clean up the words on the trophy. The Vice Commander took this task for action.

The meeting was adjourned at 10:44 p.m.

Friday, May 2, 2003 - Racing Rules Seminar; 6:30 p.m. at the Clubhouse. SMSA members and U.S. Sailing judges, Stovy Brown and Dan Trammell will again present the Racing Rules of Sailing Seminar. The seminar is planned as a repeat of the February seminar with assurance that with different participants, the interpretations, questions and discussion from the audience, will be just as challenging and informative.

Friday, May 9, 2003 - Protest Procedures Seminar; 7:30 p.m. at the clubhouse. SMSA member Barbara Herbig will present the process and procedures involved in protesting someone for an infraction of the Racing Rules of Sailing. Discussion will include: what makes a protest valid, hearings, arbitration, and appeals from both a racer's perspective and that of a protest committee. Attendance is encouraged for persons who actively race, sit on protest juries or wish to learn more about this often overlooked portion of the rules. Cruisers who used to race will be welcome participants to potentially serve on juries for the multiple race program events.

Friday, May 16, 2003 - Sailing Tactics for Women; 7:30 p.m. at the Holly II building. SMSA member Dan Trammell will present Sailing Tactics to the women sailors of SMSA. Women are encouraged to attend to polish up their skills and expand their knowledge of tactics. Men are welcome to attend, although the presentation is developed for women. Participants are asked to bring something to share with coffee after the presentation. A little something for you and to share with another is plenty.

Friday, May 30, 2003 - Marcy Series Skippers' Meeting; 7:30 p.m. at the clubhouse. Skippers and crew are encouraged to attend.

Saturday, May 31, 2003 and Sunday, June 1, 2003 - Marcy Series Women's Program races; details can be found in the SMSA race circular when available or handed out at the Skipper's meeting. To encourage participation by ALL, provisional ratings will be given to boats without a valid PHRF certificate. Racing will be followed by the Luau rendezvous at Zahniser's on Saturday and a Mini-rendezvous at the clubhouse on Sunday.

As you can see, the Women's Program has a full schedule this month that finishes with the Marcy Series, which is one of the major program events of the year. Much discussion has transpired over the years on the rules surrounding the women's program racing events. These discussions have included whether or not to have spinnaker and/or non-spinnaker starts, allowing male advisors or male boat owners on board and rating penalties for doing so. This year there are some new ideas about how to promote the most participation while keeping things as fair as possible for all sailors. One new idea is to have a class that includes no males allowed and one that does. This year we have lost the participation of the Navy Patuxent River Sail Club boats that have been very active participants in previous years' women's program races. This situation and others may lead once again to having more sailors interested in racing than boats to put them on. Input is needed from both the women and men sailors of SMSA on how to increase participation and maintain a level of fairness. Your comments and ideas on this are welcome and encouraged. Please pass any ideas that you may have on to the Women's Program governor or any member of her committee. All input will be appreciated.

## BOAT BIOS

From Bob Reid: I got started in sailing in 1970 by

racing Albacores at the Red Dragon Canoe Club on the Delaware River, in New Jersey just across the river from Philadelphia. I raced Stars at Tred Avon and at West River, and then I moved up to Cal 25's, and ultimately to a pretty well outfitted Seafarer 30 that I raced PHRF for several years. Eventually, racing got to be too much like work, and too expensive, so now I have a 1982 Seafarer 30 that is pretty much exclusively a cruising boat. My boat, *Mo Rain*, got her name from a Scottish dictionary. It means "out of my mind" in Highland Gaelic. I am single and my other interests include model railroading and sports cars.

From Chuck and Ginni Stein: I learned to sail at the Naval Academy in the late 50's. In the late 60's I crewed on a 505 for a few years in Marblehead, Mass, and in the early 70's my wife and I bought and sailed a Cal-25 in Kittery Maine. We belonged to the Kittery Point Yacht Club which raced around the buoys on Saturdays in the summertime. There were two Pearson Ensigns in our fleet. The Ensign is a 22 foot keel daysailer, suitable for sailing on the coast, and a good family boat and one-design racer. I really admired them because they were fast enough to race with larger cruising boats, and small enough to use as a family daysailer.

Our children, Chuck and Jennifer, were pre-teen then, and we cruised the coast of Maine and the north shore of Massachusetts, mainly on weekend cruises. Ginni and I took a one-week cruise to Casco Bay, but the Cal just wasn't big enough to really be comfortable for that long a cruise. When our kids got to be teenagers, there was a lot of pressure to do other things at home, so in the late 70's we sold the Cal.

## THE RACER'S EDGE

It is a Sunday afternoon in March and you and your snow weary crew of *Pedal to the Metal* are looking forward to a spring Frostbite Series race. The threat of rain does not deter your enthusiasm as you and *Pedal to the Metal* charge off the starting line in a 10 knot westerly wind. Of course your



arch rival, that miscreant scumbag Poulet Poop, skipper of *Wee Willie*, is close behind you and slowly closing as you and your rusty crew are a little less than totally efficient.

However, *Pedal to the Metal* holds on to her lead over *Wee Willie* and you are breathing easier as you beat toward the finish line at the CBL pier on long port tacks and short starboard tacks. As you approach Patuxent River Red #6 Marker (where the Wednesday evening races start) you decide that holding your port tack will force you to take that Marker to port ... and cause you to sail over Solomon Flats! Since the tides are rather high, you don't see any reason why you cannot "cut" the corner so you hold your port tack, take Patuxent River Marker #6 to port and tack to starboard only when your depth sounder indicates 7 feet of water. Marker # 6 remains to port as you continue to close on the finish, and you carefully assure yourself that "Y" Mark will be taken to starboard as required.

Just before crossing the finish line you faintly hear Poulet Poop on *Wee Willie* who is still clear astern shouting, "Protest!", but you sail on confident that Poop must be hallucinating.

You go to the Protest hearing confident of Victory ... but the Protest Committee quickly throws you out of the race! Why?

The SMSA 2002 Race Circular, under which the 2003 Spring Frostbite Series is sailed, states in the "2002 General Sailing Instructions" paragraph 12.2 that "Patuxent River navigation marks are to be passed on the channel side at all times." You and *Pedal to the Metal* cut the corner and sailed on the Solomon Flats side of Marker #6, and therefore you failed to pass the navigation mark on the channel side. Thus your disqualification!

It looks like it is going to be another one of those years for *Pedal to the Metal*...
